Lunchtime Webinar: Thursday 1 December 2022 at 1:00 pm (CET) / 12:00 pm (UK)

The LIDC will be holding a joint lunchtime webinar with the CLA on **Thursday 1 December** at 1:00 pm (CET) / midday (UK).

Stijn Huijts has kindly agreed to speak on the following subject:

"Exclusive dealing after Intel, Qualcomm and Google (Android) - a farewell to formalistic analysis?"

The session will be moderated by Sophie Lawrance, Bristows LLP.

Stijn Huijts will discuss the recent General Court judgments in Intel, Qualcomm and Google (Android) and focus on two interesting parallels. Not only did the Court set aside the European Commission's formalistic approach to exclusive dealing in these cases, it also criticised the Commission's procedure, even going as far as saying that the procedural errors were sufficient for annulment of the entire decision in the Qualcomm case. Sophie and Stijn will discuss whether we have seen a permanent shift away from a formalistic approach to exclusive dealing, and whether the Commission's errors on the substance are in part linked to the procedural errors identified in these cases.

Stijn Huijts is a Partner at Geradin Partners. Before joining the firm, Stijn was Legal Director at the UK's Competition and Markets Authority (CMA).

Stijn has significant experience in abuse of dominance cases, leading the legal teams in the *Hydrocortisone* and *Fludrocortisone* cases, as well as acting both on the defence side and the complainant side in private practice. Stijn also led on the CMA's defence in procedural issues, including in the High Court and Court of Appeal in the first ever challenge against a judicial warrant to enter business premises.

Stijn also led the CMA's legal preparations for Brexit, advising the UK Government on the legislation and guidance required to prepare the UK's competition regime for Brexit. In addition, he represented the UK in its final competition intervention in the EU Courts in Case T-399/16 CK Telecoms v Commission.
